## **REPORT OF THE INTERIM SUPERINTENDENT** – Dr. Gary P. McCartney

- On Wednesday, April 19<sup>th</sup> and Thursday, April 20<sup>th</sup> our district experienced an issue with the internet connections that impacted PARCC testing. The issues have been resolved and parents of students that were impacted were notified through email.
- Thursday, April 27 is "Take Your Child to Work Day" students in grades three and over will be excused for the day if they attend work with their parents.
- A Social Media Symposium, sponsored by the South Brunswick Parent Academy will be held on Saturday, April 29<sup>th</sup> at Crossroads South Middle School from 9:00 am – 11:00 am. Childcare will not be provided.
- The public budget meeting scheduled for this evening has been postponed until May 8, 2017.
- The South Brunswick School District has been named a 2017 Best Communities for Music Education by the NAMM Foundation for its outstanding commitment to music education. South Brunswick is 1 of 37 districts in New Jersey and 1 of 527 school districts across the nation to receive this honor. Thank you to the board of education for providing the funding of the programs, the music educators for developing the talent of the students, and administration for all they do the make the program successful.
